







PREAMBLE

"In providing for the regulation of admission of foreigners to, their residence in, and their departure from the Republic and for matters connected therewith, the Immigration Act aims at setting in place a new system of immigration control which ensures that-

(a) visas and permanent residence permits are issued as expeditiously as possible and on the basis of simplified procedures and objective, predictable and reasonable requirements and criteria, and without consuming excessive administrative capacity"


1. Do you find that your organisation struggles to recruit critically skilled individuals?



3. Do you perceive the work visa process as a prohibitor to recruit internationally?




2. Would international search help you to find these skills?

- When does someone come for "business" vs "work" in South Africa?
- The Immigration Act defines "work" as including -
 - "(a) conducting any activity normally associated with the running of a specific business; or
 - (b) being employed or conducting activities consistent with being employed or consistent with the profession of a person, with or without remuneration or reward, within the Republic."
- We have seen various arrests in this regards
- In cases of doubt, apply for a section 11(2) visitors visa





- Issued to frequent business travellers
- Up to 10 years with each visit not exceeding 30 days
- Turnaround time of 5 working days upon application (once off)
- Not a work visa (may still need 11(2) visas)





- Department of Labour Certificate
- Waivers







- 62% of expatriate assignments fail due to spouse unhappiness
- Critical Skills Work Visa for Spouses





- Arbitrary and varied requirements for visas
- Inconsistent turnaround times





- The visa category that you obtain cannot compromise the tax and exchange control treatment of expatriates
- Certain categories trigger tax and exchange control residency
- We have a "rule" that all visa applications must have a tax and exchange control signoff by one of our tax attorneys





- A work visa involves up to 50 steps in terms of preparing and submission of an application
- These steps involve both the expatriate and employer
- At least 10 steps must be done by the expatriate or employer (others can be outsourced)
